Dear Member

As mandated by the Managing Committee at its 216th Managing Committee meeting held on July 09, 2024 at Pondicherry, the following Elections Notice & Guidelines are being issued.

- 1. All members of the ALL INDIA MOTOR TRANSPORT CONGRESS (hereinafter referred to as AIMTC) are hereby informed that the Election of Members of the Managing Committee of AIMTC for All STATES / UTs and the PRESIDENT (to be elected from North Zone) and THREE VICE PRESIDENTS (one to be elected from West, East and South Zone each) for a period of two years.
- 2. The Election Schedule is being issued for the Election of Members of the Managing Committee of AIMTC for All STATES / UTs for the term 2024-2026 and it will be displayed on AIMTC website viz., www.aimtc.org. The Government of India guidelines for paperless / contactless communications are being adhered to. Members can view and download the Election Schedule & Nomination Form from the AIMTC website.
- **3.** Any individual or duly authorized representative on behalf of firm, company, co-operative society, association or any legal form of combine, whose name appears in the VOTERS LIST, issued by the Chief Election Officer, incompliance to the guidelines issued in this Election Notice shall only be eligible to vote, contest and participate in the election, as laid down in Articles of Association.
- **4.** Every member whose name is included in the eligible voter list shall have the right to cast only One Vote for Each Seat in their respective STATE / UT. One Aadhar Card shall have One Vote only as per Bye Laws.
- **5.** The Chief Election Officer may adopt any mode / procedure / process for conducting elections as he deems fit, in accordance with the mandate given by the Articles of Association, which shall be declared post declaration of final list of contesting candidates.
- **6.** Any Process / Procedure of the Election Process, any part or thereof, could be conducted by the Chief Election Officer, either from the **Camp Office or Head Office**, as per the discretion of the Chief Election Officer.
- 7. Interested candidates are required to fill the enclosed Nomination Form complete in all respect, which must reach the office of the AIMTC on or before 26-10-2024 by 5:00 P.M., in properly sealed envelope by POST containing endorsement outside the envelope "NOMINATION PAPERS FOR THE MANAGING COMMITTEE MEMBER OF AIMTC FOR [STATE / UT]" alongwith the MEMBERSHIP NUMBER addressed to:-

- **8.** The Nomination Papers shall be acceptable **only by Speed Post** / **Regd. Post** to be delivered in the office of AIMTC under acknowledgement from the place, where the member has its authorized address. No Nomination Form will be accepted by Hand, in any case.
- 9. Every Nomination must be only on the "NOMINATION FORM" enclosed herewith. Each Nomination must be accompanied with a Bank Draft of Rs. 35,000/- (Rs. Thirty Five Thousand only) drawn in favour of All India Motor Transport Congress payable at New Delhi. The draft should be crossed and endorsed "A/C PAYEE ONLY".
- **10.** The Nomination fee shall be **NON-REFUNDABLE**, **NON-ADJUSTABLE AND NON-TRANSFERABLE** in any case.
- **11.** The Nomination Form, complete in all respects, duly filled in Clear handwriting in CAPITAL LETTERS, signed & stamped, along with requisite enclosures.
- 12. Self Attested copies of Aadhar Card and PAN Card must be enclosed with the Nomination Form.
- 13. Any Nomination Form containing incorrect, false or incomplete information or suffering from suppression of any material fact shall be liable to be rejected.
- **14.** Resolution / Authorization must be enclosed in case of the Firm, Company, Association, Union, Syndicate, Federation / Confederation / Chamber/ Society,
- **15.** The Nomination filed on behalf of any Firm, Company, Syndicate or any legal form of combines must be accompanied by proper resolution on the Original Letter Head of the entity, duly signed & stamped, passed by Board of Directors (BoD).
- **16.** In case of Company MasterData (Document of MCA) reflecting the name of authorized representative as one of the Board of Directors (BoD) must be accompanied with the Nomination Form;
- **17.** The Nomination filed on behalf of Partnership Firm, shall be accompanied with written authorization, duly signed & stamped, by all existing partners on the Original Letter Head of the Firm.
- **18.** The Nomination filed on behalf of Association, Union, Syndicate, Federation / Confederation / Chamber/ Society must be accompanied by Proper resolution on the Original Letter Head of the Entity, duly signed & stamped, by the Office Bearers of the Association, Union, Syndicate, Federation / Confederation / Chamber / Society.
- **19.** Resolution / Authorization, authorizing the Nomination shall mention that the incumbent representative shall continue to be the member of the Managing Committee of AIMTC as long as he enjoys authorization by the said Firm, Company, Association, Syndicate or any legal form of combines.
- **20.** Voter list will be listed on the website: www.aimtc.org, however it shall also be available in the office of AIMTC, 1/16A, Asaf Ali Road, New Delhi during working hours at cost of Rs. 1000/- per list per State / UT, payable to AIMTC.
- **21.** Ballots if returned back to the AIMTC Office due to any reason will not be send back to the member in any case.
- **22.** Ballots will be despatched by AIMTC Office through Speed Post, in case it is not received by any member, for any reason whatsoever, the undersigned or the AIMTC office is not liable for the same.
